Revisión Bibliográfica 2020

En línea con los objetivos de la Cátedra Hestia, y tal como hicimos en años anteriores, hemos elaborado un documento donde se incluyen las publicaciones científicas más relevantes generadas el año 2020 en el Estado español y relacionadas con las áreas de interés de la cátedra (atención integrada, cronicidad, multimorbilidad, dependencia, necesidades sociales, centros sociosanitarios y residencias), con especial atención a aquellas que incluyen una evaluación del impacto de la COVID-19.

El documento clasifica los estudios en función de diversas variables (palabras clave, factor de impacto de la revista donde se ha publicado, nivel de multicentricidad (en su caso) y comunidad(es) autónomas donde se ha realizado), permite acceder directamente al resumen de cada artículo (mediante un enlace con PubMed), e incluye un mapa interactivo con la localización geográfica de los centros donde se han realizado.

Metodología

- 1) Revisión de los artículos publicados el año 2020 en la revista de referencia internacional sobre atención integrada (International Journal of Integrated Care)
- 2) Selección de las palabras clave definidas en los artículos y relacionadas con las áreas de interés de la cátedra (integrated care; delivery of health care, integrated; social services; cross-sector service delivery; service integration; community based primary health care; innovative models of care; chronic conditions; chronic patients; chronic diseases; patient complexity; transitional care; home hospitalization; complex care needs; multimorbidity; integrated care systems; integrated policy; nursing home; COVID-19)
- 3) Búsqueda bibliográfica en PubMed utilizando cada una de las palabras claves + Spain + year 2020
- 4) Selección de aquellas publicaciones consideradas de interés por su relación con las áreas de interés de la cátedra.
- 5) Elaboración de una base de datos en formato excel donde figuran los siguientes indicadores: palabra clave utilizada en la búsqueda, título del artículo (con el enlace al resumen en PubMed), revista donde se ha publicado, factor de impacto de la revista (2019), institución del primer autor, comunidad autónoma, ciudad y ámbito (internacional, estatal o autonómico)
- 6) Elaboración de un mapa en GoogleMaps de los centros del estado español que figuran en el listado de publicaciones.

Resultados

Se han seleccionado un total de 85 art culos

Los art culos, en base a las palabras clave utilizadas en la selecci n, se han agrupado en seis cap tulos: "integrated care" (31), "chronicity" (22), "multimorbidity" (13), "nursing home & COVID19 (12), "social services" (4), "home hospitalization" (2) and "transitional care" (1)

Solo una parte de los estudio son cl nicos (intervenci n y sus resultados en pacientes). El resto es una miscel nea de revisiones bibliogr ficas, descripci n de proyectos, temas de gesti n, medici n y evaluaci n, modelos organizativos, etc,...

La mayor a de estudios son multic ntricos (25 internacionales, 14 estatales y 19 a nivel de comunidad aut noma)

El n mero de publicaciones por Comunidades Aut nomas es el siguiente: Catalu a (41), Andaluc a (16), Pa s Vasco (13), Madrid (10), Arag n (8), Comunidad Valenciana (4), Navarra (3), Canarias (2), Castilla La Mancha (2), Murcia (2), Asturias (1), Baleares (1), Castilla Le n (1) y Galicia(1).

Conclusiones

La evidencia cient fica en relaci n a la atenci n sociosanitaria integrada generada en el estado espa ol en el periodo analizado (2020) se ha incrementado substancialmente en relaci n a a os anteriores. Una parte importante sigue m s relacionada con el dise o y valoraci n te rica de modelos organizativos que con intervenciones cl nicas. Los aspectos sociales siguen poco representados. Gran parte de los estudios son multic ntricos, aspecto muy positivo e imprescindible para aportar evidencia cient fica en temas de integraci n de servicios. Catalu a es la Comunidad Aut noma con mayor n mero de publicaciones, seguida de Andaluc a, Pa s Vasco, Madrid y Arag n.
